One Time Opportunity Scheme Examinations who studied the 3/5 years LL.B Course under Semester System of admitted batches upto **Y11L** for 3 Years LL.B. and **Y9FL** for 5 Years LL.B. and admitted batches of Year end pattern (Non-Semester) of LL.B. Course upto **Y2LO** batches who could not complete their Theory Backlog papers within the stipulated period of six years/eight years from the date of joining into Course. The examinations application should be duly signed by the concerned Principal of the College in Guntur, Prakasam and Krishna Districts where they have studied earlier.
