With reference to the above, I am by direction to inform you that the facility for <u>One Time Opportunity Scheme</u> has been extended to B.Tech. students for the completion of B.Tech. Course those who are having backlog papers in Theory and Labs for the students admitted in the academic year 2007-08, 2008-09 & 2009-10 (Regular-Y7, Y8, Y9 Batches) and for Lateral Entry Candidates admitted into II/IV B.Tech. for the batches of Regular-L8, L9, L10 as the locking period (of 8/6 years) was expired for completion of the B.Tech.
